Authorization

1. I, the undersigned, hereby authorize Manitoba Public Insurance (“MPI”) to use the applicant’s personal information, including the applicant’s personal health information, to:
 - a. Administrate the Driver Z Program (the “Program”);
 - b. Verify the applicant’s eligibility to participate in the Program; and
 - c. Confirm the ongoing validity of the applicant’s driver’s licence.
2. I, the undersigned, further authorize MPI to access the Insurance Work Station to conduct searches of the applicant’s driving history abstract in order to:
 - a. Verify the correctness of the applicant’s name as it appears on this application;
 - b. Verify the applicant’s eligibility to participate in additional driver education programs run by MPI;
 - c. Confirm the ongoing validity of the applicant’s driver’s licence;
 - d. Send the applicant correspondence associated with the Program; and
 - e. Conduct annual assessment of the impact of the Program on the applicant’s driving habits and driving record.
3. I, the undersigned, agree to the disclosure of the applicant’s course information in the Driver Z online website to the applicants’ co-pilots.
4. I, the undersigned, acknowledge that this application is the first step in the process of the applicant applying for a Manitoba driver’s licence, and authorize MPI to take a photo of the applicant, and to have the applicant’s identification documents verified to determine eligibility for the licence.
5. I, the undersigned, understand that the undersigned parent or legal guardian has the right to submit, in writing, a request to the Registrar to cancel the applicant’s licence while the applicant is a minor.
6. I grant permission to the applicant documented in this form to apply for driver testing services online. Yes No
7. I, the applicant, agree that any school computers used in the Driver Z Class 5L test will be used for the sole purpose of accessing an MPI website and completing the Class 5L Driver’s Knowledge Test. Any other use whatsoever during testing may result in my immediate expulsion from the Program. I, the applicant, also agree that I shall be responsible for any damage I may cause the room, equipment, or network in the computer lab and will abide by any other rules that are posted in the school computer lab.
8. I, the applicant, agree to notify MPI of any changes to my school enrollment information listed above that occur prior to my completion of the Program.
9. I, the undersigned, agree to fully reimburse MPI for all traffic infractions, tickets or fines incurred by the applicant while operating a Driver Z training vehicle. Including but not limited to infractions captured by traffic enforcement cameras, and that the failure to pay the full amount of the ticket or fines by the applicant, parent or legal guardian of the applicant may result in collection actions being taken by MPI against the applicant, parent, or legal guardian of the applicant, and/or suspension or expulsion of the applicant from the Program without a refund.
10. I, the undersigned, further acknowledge that I am aware that the Program instructors are independent contractors retained by MPI and are not officers or employees of MPI. I do hereby waive any right of action, for any cause whatsoever, which I may now, or at any time in the future, have against MPI, or its directors, officers, shareholders, employees, subcontractors, partners, volunteers, agents, delegates and other representatives, arising out of the participation in the applicant in the Program, or arising out of an incident or incidents occurring during the course of the Program resulting in the injury, disability, or death of the applicant (apart from any benefits to which the applicant, parent or legal guardian, may become entitled to pursuant to the Personal Injury Protection Plan).
11. I, the undersigned, hereby acknowledge that I have read, understand and agree to these terms and conditions for the applicant’s enrolment in the Program, the course requirements, and the conditions by which a learner’s (“Special” Class 5) licence may be acquired and cancelled. I, the undersigned, also agree to comply with [MPI’s Driver Z Program Registration Guide](#), as published on the Manitoba Public Insurance website, which shall be incorporated as additional terms to the Driver Z application.

I understand that in order to be eligible for a Manitoba Driver’s Licence, I must sign a consent form permitting MPI to verify my birth certificate information with the Manitoba Vital Statistics Agency, as referenced in the Consent to Manitoba Public Insurance and The Manitoba Vital Statistics Agency Sharing My Information, and the *Notice of Collecting and Sharing of Your Personal Information by Manitoba Public Insurance* provided to me.
